### **NEW BUSINESS**

- 1. New budget preparation and Tax Cap—of 1.7%
  - a. Minimum wage goes up to \$12.50 in December.
    - i. Effects the contribution to Social Security, Compensation, etc.
  - b. Keep an increase just below the tax cap rather than going to the top.
  - c. We could raise our request at 1.65%...We would get \$1393 with this raise.
    - We must ask for an increase. Eric moved we ask increase. Julie seconded.
      Passed.
  - d. Last year's total was \$84,363
  - e. NYS is holding back on grants retroactively...basically 'stealing money'.
  - f. Budget needs to be presented to the Club in November
- 2. Consider consolidating the Club and the Board since Club membership is so small.
  - a. Neither one has a full complement of officers.
  - b. Brian Hildreth can help us work this out. Eric will start the conversation going.
  - c. The club has the option of giving the library to whoever they wish so why not give it to the Board. If they give it to the Board it remains tax exempt.
